## EVENT RULES FOR COVID-19 REQUIREMENTS

These rules will be enforced throughout all events held on these grounds June 18 through June 20, 2021, and apply to all events - Cascade Hound Association, American Whippet Club, Cascade Whippet Club, Evergreen Afghan Hound Club, and Afghan Hound Club of Greater Portland. These rules also apply to set-up and takedown periods. Updates or changes to these rules will be published in the judging schedule.

Entrance to these events is restricted to exhibitors, owners, handlers, and show officials. No spectators are allowed. Access to the grounds may be limited for time or duration, dependent on Covid-19 restrictions in place at the time of these events.

All attendees must sign the Covid-19 Event Waiver to enter the grounds. A wristband will be given to each attendee upon signing the waiver, which must be worn at all times at all events. You **MUST** have a wristband to pick up any armbands.

Face masks **MUST** be worn at all times on the grounds, including while exhibiting in the show rings. Face masks must adequately cover both the nose and mouth. No exceptions will be allowed.

Attendees must maintain social distancing guidelines of 6 feet from others on the grounds; "family units" may be excepted. This includes ringside seating and waiting to enter the show rings.

Canopy set-ups will be allowed on the grounds, subject to social distancing guidelines. Please be aware that attendee occupancy of these set-ups **MAY** be subject to limited hours or a limited number of occupants, dependent on Covid-19 attendance restrictions in place at the time of the events.

Attendees must comply with all instructions given by show officials or designated Covid-19 monitors.

## NO PRACTICING ALLOWED IN RINGS AT ANY TIME

**Dogs may arrive** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

**Judges Will Not Wait for any Dog Holding Up A Class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

**All Dogs Present** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**No gasoline or diesel generators** are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

**As specified in Chapter 12, Section 4** of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

The winners of these classes will be eligible to compete for Best of Breed. Any veterans defeated in these classes may not compete for Best of Breed, even if entered in the class. Neutered dogs and spayed bitches are allowed to compete in Veterans Classes only at independent specialties shows.

### Best of Breed Competition

The following categories of dogs may be entered and shown in Best of Breed/Variety Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed/Variety Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

### Grand Champion Competition

The following categories of dogs are entered in this competition:

1. Dogs that are Champions of Record competing in Best of Breed or Best of Variety class. There are no additional entry fees or cost to exhibitors for participation in this competition at AKC events.
2. Dogs transferred to Best of Breed/Variety which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed.
3. Champions that win Non-Regular Classes and become eligible for Best of Breed competition (Altered or spayed CH veteran class winners at independent specialties are eligible).

4. Winners Dog and Winners Bitch are not eligible for Champion competition. And their winning BOB/BOV or BOS will still allow the awarding of Select Dog/Bitch to eligible dogs in the ring.
- At the judge's discretion, Grand Championship points may be awarded to: 1. Best of Breed or Variety. 2. Best of Opposite Sex. 3. Select Dog. 4. Select Bitch. Grand Champion competition will not continue beyond Best of Breed completion and in breeds that are divided into varieties, Grand Champion Competition will not continue beyond Best of Variety competition.

**Awards of Merit for both clubs** - At the judge's sole discretion, Awards of Merit may be awarded in recognition of those entrants in the Best of Breed competition who are in serious consideration for the top award, as follows: one (1) AOM if nine (9) or fewer champions are entered; two (2) AOMs if ten (10) or more champions are entered. Whether any Award(s) of Merit are awarded is entirely up to the judge. Recipient(s) will receive a Dark Green Rosette.

#### **Non-Regular Classes (Involving Multiple dog entries)**

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

**A castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class.**

**Stud Dog Class** – For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, but **MUST** be entered in the Stud Dog Class, the Get **MUST** be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

**Brood Bitch Class** – Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

**Brace Class - Effective 01/1/2005-** A brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace must have at least one common owner. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of brace is not entered in another class, it must be entered for "Brace Class only" An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class". **Brace is a single entry and includes both dogs. Entry fee is \$22.00**

**AKC National Owner- Handler Series** is a non-titling competition created in direct response to Owner-Handlers' desire to compete against other Owner-Handlers. Owner-Handlers will still enter and compete in the regular classes to win Best of Breed. Then, just before the regular class judging is complete, the recognition of Owner-Handler Best of Breed will be awarded. Judging Procedures for the AKC National Owner-Handled Series  
Determining Exhibitor Eligibility: The first step in judging the AKC National Owner-Handled Series is determining exhibitor eligibility. Follow these tips to properly make the eligibility determination: Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the check box on the entry form.

- The handler must be an owner of record according to the AKC's records as of the date of the show.
- Dogs declared eligible will be identified by an asterisk or other representative mark in the steward's book and in the show catalog.
- Professional handlers, household members and current assistants to professional handlers may not exhibit. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.
- Dogs must be handled by an owner-handler eligible for the AKC National Owner-Handled Series throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner-handler for all AKC National Owner-Handled Series competition.
- The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. This excludes all dogs defeated during class and winners competition for the regular show.
