General Information: The building will open at 7:00 am on Tuesday, May 27th for the Obedience and Rally Trial. Your dog(s) must be on leash at all times except when in the ring. You may park in any spot that is not reserved for the judge or trial committee.

Please enter the building through door #3 only. Do Not Use Any Other Door!
 We have our ring set up in the front and middle space of the building.

Crating: There will be crating space available in the building along with a small practice area. Please bring a mat for under your crate. Ex-pens are not allowed. Do not leave water bowls on the floor for access by others. Do not leave the top of your crate open. You may also bring a chair to set up in front of your crate. If you are bringing more than (1) dog, we ask that you stack your crates since space is limited.

Potty Areas (for you and your dog): Please use the Port-A-Potty located in the parking lot. The bathroom inside the facility is reserved for the judge and trial committee only.

Potty area for your dogs is located behind the facility. Please clean up after your dog and place waste in the receptacles provided. **DO NOT** allow dogs to urinate on the building or cars.

Hospitality: We will have a small hospitality area set up in the crating area. Coffee, water, snacks and bagels will be available all day (or until they run out). Donations are welcome!
