Chapter 11, Section 1. No dog can enter a licensed or member dog show unless it is either; individually registered with the American Kennel Club, or is individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. For complete detail, see Rules Applying to Dog Shows, Chapter 11. Section 1. The American Kennel Club will collect a \$3.00 event service fee for the first entry of a dog, and a \$3.50 service fee for each additional entry of the same dog in the regular and nonregular recordable single entry classes, in all AKC licensed and member club events. (American Kennel Club Rule, Chapter 11, Section 2). The current 50 cents recording fee will continue to be collected where applicable. The event-giving Club shall be responsible for collecting all the Events Service Fees for the American Kennel Club. The American Kennel Club must receive all fees within seven (7) days of the close of the event, along with all other required event results.

ACKNOWLEDGMENTS: Entries will be acknowledged after the entries have closed. Entry acknowledgment and judging program to be sent to the address on entry. Should an exhibitor NOT receive the entry acknowledgment within a reasonable time, please notify the Show Secretary at the address provided. PSSS will not accept any entry that includes or specifies any conditions. Telephone, telegraph, fax, and unsigned entries cannot be accepted and will get returned. Entries not on Official AKC Entry Forms and photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and or Show Secretary assumes no responsibility for wrong or incomplete information given on the entry blank by the dog owner or agent who entered a dog in a class that the dog is not eligible to compete in. THE RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT.

PSSSS will not refund any Entry fees if a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, barred from competition by action of the Show Committee, or because it was entered incorrectly. There is no refund of the entry fee for bitches in season, except for bitches enter in Junior Showmanship, Obedience, or Rally. There is no refund for DUPLICATE ENTRIES OR, because of riots, civil disturbances, or other acts beyond the control of the management, if it is impossible to hold the show.

No dogs will be allowed in the show area except those entered. The judging will start promptly. Dogs may arrive anytime before their time of judging and may leave immediately afterward unless required for further judging. Exhibitors are responsible for having their dog ready to be shown and at the entrance of the judging

ring when the steward calls for the class.

FOR LOSS AND OR DAMAGES: The Show Committee will use due care and diligence for the welfare of dogs and exhibitors. The Show Committee and Event Secretary will not be responsible for or assume any liability in the case of any injury or misfortune to either dogs or exhibitors participating in this event. The responsibility and welfare of an exhibitor's child are assumed to be the exhibitor's responsibility. All exhibitors will exercise control and restraint over their children on the day of the show.

#### POINTS FOR RESERVE

Chapter 16 Section 1 Rules Applying to Dog Shows ... at the National Specialty the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held.

#### NON-REGULAR CLASSES (INVOLVING SINGLE DOG ENTRIES) Field Class

Field Class Dog: Open to any English Cocker Spaniel Dog or Bitch eligible to regularly compete at a show that has earned the ECSCA Working Dog (WD) or Working Dog Excellent (WDX) Title, or an AKC Field Championship (FC), Hunting Title (JH, SH, MH) or has placed in a stake at an AKC Cocker/English Cocker Spaniel Field Trial. Chapter 11, Section 8 of the "Rules Applying to Dog Shows" Neutered dogs and spayed bitches would be allowed to compete in the Field Class. Judging will be on conformation only, and the winner of the Field Dog and the Field Bitch classes may compete for Best of Breed Competition if otherwise undefeated in a breed class at this show.

#### Veteran Class

Veteran Classes - Class for dogs & class for bitches seven (7) yrs & under ten (10) yrs. Veteran Classes - Class for dogs & class for bitches ten (10) yrs & over. Chapter 11, Section 8 of the "Rules Applying to Dog Shows" Neutered dogs and spayed bitches would be allowed to compete in Veterans and all other single entry non-regular classes only at independent specialties and/or those all-breed shows which do not offer any competitive classes beyond Best of Breed. Winners of the Veteran Classes will compete for Best of Breed (Variety), if undefeated.

#### BEST OF BREED COMPETITION

NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES) Stud Dog Class - For Stud Dogs and two (2) of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of the Get. Award will be based on the merits of the Get. While the merit of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determined if it has a condition that would require its disqualification or excusal under Dog Show Rules, AKC policy or the Standard for the breed. If the Stud Dog or Get are not entered in one of the other classes at this show for which it is eligible, the regular entry fee of \$35.00 must be paid for each. Entry fee for the Stud Dog Class as an "Additional Class" is \$29.00 for the unit.

**Brood Bitch Class** - Same as Stud Dog Class, except substitute Brood Bitch for Stud Dog and Produce for Get. Note; in Accordance with Chapter 11, Section 8, a neutered male may be entered in the Stud Dog Class and a spayed bitch may be entered in the Brood Bitch Class.

The Stud Dog and Brood Bitch Classes that are traditionally judged after Best of Breed has concluded, will be judged on Thursday. Margie Wilson will judge both classes. The entry criteria remain the same as stated above.

Brace Class - For Two (2) dogs of the same breed and which must have one common owner and be presented by a maximum of two handlers. All Braces must be entered in the Brace Class and shown in the ring at the same time. Dogs may be entered for Brace Class competition only or as an additional entry. The dogs comprising Brace must be named at the time of the entry. In making entries for "Brace Class only", all particulars must be given for each dog on individual regular entry forms. An entry for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space for "Additional Classes". If more than one Brace is entered by the same owner, the dogs comprising each Brace must be so designated. "Brace No. 1", Brace No. 2". Entry Fee for Brace as a first entry is \$35.00 per dog and \$29.00 for the unit as an "Additional Entry".

**Team Class** - Same as Brace Class, except for Four (4) dogs of the same breed which must have one common owner and be presented by a maximum of four handlers. Entry fee for **Team as a first entry is \$35.00 per dog and \$29.00 for the unit as an "Additional Entry".** As the judge's decision in the Stud Dog, Brood Bitch, Brace and Team Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged First in the class will be eligible for Best of Breed by virtue of having won these classes.

The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. Family members must be both a breeder and owner of record to exhibit in the class. Any entry in the Bred-By-Exhibitor classes that is awarded Best of Breed or Best of Winners would automatically be Best Bred-By-Exhibitor. Only the dog or bitch not defeated in Bred-By-Exhibitor Class are eligible for the Best Bred-By-Exhibitor competition. Best Bred-By-Exhibitor will be selected from the winners of the Bred-By-Exhibitor Puppy Classes (6-12 mos.) and the Bred-By-Exhibitor Adult Classes (12 mos. and over) at the conclusion of Best of Competition.

- A responsible adult must be present with the child both inside and outside the ring.
   The adult is to maintain control of the dog outside of the ring.
- A release must be signed by the child's parent or legal guardian. This release will be available onsite and must be signed before going into the ring.

The safety of both the dogs and juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child.

An additional lead, provided by The Club, will be at the Judge's tabled. At the judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

#### Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

#### Section 2 – Entry and Eligibility

Entry and eligibility requirements include: AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows. A foreign born dog may enter this class if they are registered in the country of origin.

All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

Professional handlers are not permitted to exhibit in this class. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

Classes will not be divided by sex in this competition. The show results and event service fee of \$2.00 per entry must be submitted to AKC Event Operations within seven (7) days of the event (electronic results submissions are preferred). Clubs holding Four-to-Six Month Puppy competition will receive credit for completing both a Major Activity as well as an Additional Activity for judges gaining experience on their unapproved breeds by judging at the event. Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise.

Exhibitors should open their dog's mouth for examination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs. Male puppies without 2 fully descended testicles need not be disqualified or excused but the judge's book must describe the condition and Certificate of Merit points must be withheld. Dogs with breed standard disqualifications should not be excused but may not receive placements. However, dogs with age related disqualifications such as color (as related to age), height, teeth etc. are permitted to receive awards in the 4-to-6 Month Puppy classes. Dogs must be excused for attacking a person or other dogs. No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed.
