Attention Exhibitors

Exhibitor Rule Change Effective 01/01/2010. Chapter 11, Section 1.

No dog can enter a licensed or member dog show unless it is either: individually registered with the American Kennel Club, or is individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. For complete detail, see Rules Applying to Dog Shows, Chapter 11, Section 1.

Effective for all events held on and after January 1, 2008 The American Kennel Club will collect a \$3.00 event service fee for the first entry of a dog, and a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC licensed and member club events. (American Kennel Club Rule, Chapter 11, Section 2). The current 50 cents recording fee will continue to be collected where applicable. The event-giving Club shall be responsible for collecting all the Events Service Fees for the American Kennel Club. The American Kennel Club must receive all fees within seven (7) days of the close of the event, along with all other required event results.

ACKNOWLEDGEMENTS: Entries will be acknowledged after the entries have closed. Entry acknowledgment and judging program to be sent to the address on entry. Should an exhibitor NOT receive the entry acknowledgment within a reasonable time, please notify the Show Secretary at the address provided. PSSSS will not accept any entry that includes or specifies any conditions. Telephone, telegraph, fax, and unsigned entries cannot be accepted and will get returned. Entries not on Official AKC Entry Forms and photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and or Show Secretary assumes no responsibility for wrong or incomplete information given on the entry blank by the dog owner or agent who entered a dog in a class that the dog is not eligible to compete in. **THE RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT.** PSSSS will not refund any Entry fees if a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, barred from competition by action of the Show Committee, or because it was entered incorrectly. **There is no refund of the entry fee for bitches in season, except for bitches enter in Junior Showmanship, Obedience, or Rally.** There is no refund for DUPLICATE ENTRIES OR, because of riots, civil disturbances, or other acts beyond the control of the management, if it is impossible to hold the show.

No dogs will be allowed in the show area except those entered. The judging will start promptly. Dogs may arrive anytime before their time of judging and may leave immediately afterward unless required for further judging. Exhibitors are responsible for having their dog ready to be shown and at the entrance of the judging ring when the steward calls for the class.

FOR LOSS AND OR DAMAGES: The Show Committee will use due care and diligence for the welfare of dogs and exhibitors. The Show Committee and Event Secretary will not be responsible for or assume any liability in the case of any injury or misfortune to either dogs or exhibitors participating in this event. The responsibility and welfare of an exhibitor's child are assumed to be the exhibitor's responsibility. All exhibitors will exercise control and restraint over their children on the day of the show.

The Club has the right to substitute a prize for equal or more value. Trophies must be claimed on the day of the show. No prizes will be mailed or otherwise distributed.

SWEEPSTAKES CASH PRIZES are awarded to the handler showing the dog while in the ring. Prize Money Claims for the prize money must be made while in the ring and before the breed judging is over. The Show Secretary and The Club disclaim any liability for cash prize after the Breed judging is over.

ALL PERSONS ATTENDING THIS DOG SHOW waive any claim for damages against THE CLUB, its members, or agents in the event that a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

THE CLUB, ITS SHOW SECRETARIES, THEIR AGENTS, EMPLOYEES, ETC., WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS BUT WILL ASSUME NO RESPONSIBILITY FOR ANY LOSS, DAMAGE, OR INJURY SUSTAINED BY EXHIBITORS, HANDLERS, OR TO ANY OF THEIR DOGS OR PROPERTY PARTICIPATING IN THESE SHOWS, AND FURTHER ASSUMES NO RESPONSIBILITY FOR INJURY TO CHILDREN AT THESE SHOWS.

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- *Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.*
- *Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.*
- *Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.*
- *The sportsman judge judges only on the merits of the dogs and considers no other factors.*
- *The sportsman judge or exhibitor accepts constructive criticism.*
- *The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.*
- *The sportsman exhibitor refuses to compromise the impartiality of a judge.*
- *The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.*
- *Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.*
- *Sportsmen welcome, encourage and support newcomers to the sport.*
- *Sportsmen will deal fairly with all those who trade with them.*
- *Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.*
- *Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.*
- *Sportsmen always consider as paramount the welfare of their dog.*
- *Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.*

****A non-refundable Dog fee of \$50.00 applies****

- The dog(s) must pose no threat to guests or hotel associates.
- Your dog(s) must be on a leash while in public areas, hallways, and Hotel grounds.
- Dogs are not permitted in dining areas, swimming pool areas, or fitness and business centers.
- Guests must crate their dog(s) in guestrooms when owners are not present. All crates must have plastic or protective sheets under them. The owner must be in the room while any hotel staff member is servicing the guestroom (housekeeping, engineering, etc.) when a dog is in the room. Dogs must be restrained or removed from the guestroom while hotel staff is present working in the room. Hotel staff will not enter any room that has an unrestrained dog.
- Suspension of all daily housekeeping if dogs are discovered unattended in a guestroom.
- All dogs must be registered at the front desk as they are allowed in designated rooms only. Registering your dog is for servicing your room and our team members' safety.

- Dogs must be in good health and up to date on all relevant vaccinations (including rabies), house-trained, clean, and free of any parasites such as ticks or fleas.

POINTS FOR RESERVE

Chapter 16 Section 1 Rules Applying to Dog Shows

... at the National Specialty the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held.

NON-REGULAR CLASSES (INVOLVING SINGLE DOG ENTRIES)

Field Class

Field Class Dog: Open to any English Cocker Spaniel Dog or Bitch eligible to regularly compete at a show that has earned the ECSCA Working Dog (WD) or Working Dog Excellent (WDX) Title, or an AKC Field Championship (FC), Hunting Title (JH, SH, MH) or has placed in a stake at an AKC Cocker/English Cocker Spaniel Field Trial. Judging will be on conformation only, and the winner of the Field Dog and the Field Bitch classes may compete for Best of Breed Competition if otherwise undefeated in a breed class at this show.

Veteran Class

Veteran Classes - Class for dogs & class for bitches seven (7) years & under ten (10) years.

Veteran Classes - Class for dogs & class for bitches ten (10) years & over.

Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that neutered dogs and spayed bitches may be entered in Veteran Classes at a Specialty that does not offer classes beyond Best of Breed. Winners of the Veteran Classes will compete for Best of Breed (Variety), if undefeated.

BEST OF BREED COMPETITION

NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES)

Stud Dog Class - Will be for Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of Get. Stud Dog only to be judged based on the merits of the Get. Get MUST be entered in one of the Regular Classes. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed.

Brood Bitch Class - Will be for Brood Bitches and two of their Produce. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. Owner of Brood Bitch need not necessarily be owner of Produce. Brood Bitch only to be judged based on the merits of the Produce. Produce MUST be entered in one of the Regular Classes. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed.

Brace Class - Two Dogs of the same breed and must have at least one common owner and presented by a maximum of two handlers. The dogs comprising a Brace MUST be named at time of entry. The dogs comprising a Brace MUST be entered in a Regular Class. An entry form for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes - "Brace Class." If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated - "Brace No. 1," "Brace No. 2," etc.

Parade of Titleholders - There will be a non-competitive Parade of Titleholders. Any English Cocker Spaniel Champion of Record (Field or Bench), Obedience Titleholder, Rally Titleholder, Hunting Test Titleholder, Agility Titleholder, or holder of an ECSCA Working Dog or Working Dog Excellent Certificate is eligible. Please include a brief resume (250 words or less) of the dog's accomplishments to be read at ringside. Entry fee: \$20.00

Award of Merit for Superior Quality: At the discretion of the judge, up to THREE Awards of Merit from dogs/bitches in Best of Breed may be awarded.

Best Bred-By-Exhibitor and BBE Eligibility - All dogs entered in the Bred-By Class must be individually registered with AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. Family members must be both a breeder and owner of record to exhibit in the class. Any entry in the Bred-By-Exhibitor classes that is awarded Best of Breed or Best of Winners would automatically be Best Bred-By-Exhibitor. Only the dog or bitch not defeated in Bred-By-Exhibitor Class are eligible for the Best Bred-By-Exhibitor competition. Best Bred-By-Exhibitor will be selected from the winners of the Bred-By-Exhibitor Puppy Classes (6-12 mos.) and the Bred-By-Exhibitor Adult Classes (12 mos. and over) at the conclusion of Best of Competition.

Best Puppy - Any entry in the puppy classes that is awarded Best of Breed or Best of Winners would automatically be Best Puppy. Only dogs not defeated in a puppy class are eligible for Best Puppy Competition.

Best in Veteran Class. - Any entry in the Veteran Class that is awarded Best of Breed would automatically be Best in Veteran Class. Only dogs not defeated in Veteran Class are eligible for Best In Veteran Competition.

Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Section 2 – Entry and Eligibility

Entry and eligibility requirements include: AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows. A foreign born dog may enter this class if they are registered in the country of origin. All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

Professional handlers are not permitted to exhibit in this class. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

Classes will not be divided by sex in this competition. The show results and event service fee of \$2.00 per entry must be submitted to AKC Event Operations within seven (7) days of the event (electronic results submissions are preferred). Clubs holding Four-to-Six Month Puppy competition will receive credit for completing both a Major Activity as well as an Additional Activity for judges gaining experience on their unapproved breeds by judging at the event. Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise.

Exhibitors should open their dog's mouth for examination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs. Male puppies without 2 fully descended testicles need not be disqualified or excused but the judge's book must describe the condition and Certificate of Merit points must be withheld. Dogs with breed standard disqualifications should not be excused but may not receive placements. However, dogs with age related disqualifications such as color (as related to age), height, teeth etc. are permitted to receive awards in the 4-to-6 Month Puppy classes. Dogs must be excused for attacking a person or other dogs. No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed.

- A dog must be at least 4 months of age to enter the Pee Wee Class.
- Bitches in season will not be allowed to participate. A dog may be substituted that meets the eligibility requirements as specified by the Club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- A release must be signed by the child's parent or legal guardian. This release will be available onsite and must be signed before going into the ring.

The safety of both the dogs and juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child.

An additional lead, provided by The Club, will be at the Judge's table. At the judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.
