Attention Exhibitors

Chapter 11, Section 1. No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. For complete detail see Rules Applying to Dog Shows, Chapter 11, Section 1.

Effective January 1, 2026 Chapter 11 Section 2

The American Kennel Club will collect a \$4.00 Event Service Fee for the first entry of a dog and a \$4.50 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. (There is no recording fee or event service fee for sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.) The current 50 cent recording will continue to be collected. The event-giving club shall assume the responsibility of collecting all Event Service Fees for the American Kennel Club. That fact shall be stated in the premium list. These event service and recording fees shall be forwarded to the American Kennel Club along with all other required event results within seven (7) days of the close of the event.

The Event Secretary shall not refund the entry fees if a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has entered incorrectly.

There is no refund of the entry fee for bitches in season unless entered in Junior Showmanship, Obedience, or Rally. Written certification by a licensed veterinarian must be received at least a half- hour before the start of all judging on the trial date is required for refund of entry fees to entrants of bitches in these trials to the effect that the bitch is in season on the day of the Junior Showmanship, Obedience, or Rally event. There is no refund for **DUPLICATE ENTRIES**. If, because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete the Show, There will be no refund of fees. No dogs will be allowed in the show area except those regularly entered in the Show. The judging will start promptly. Dogs may arrive anytime prior to their time of judging and may leave immediately thereafter unless required for further judging. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class.

LOSS OR DAMAGE: The Show Committee will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for or assume any liability in the event of any accident or misfortune to either dogs or exhibitors participating in this Event.

The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the Show.

Exhibitors should follow their veterinarians recommendation to assure their dog are free of internal and external parasites, any communicable diseases and have appropriate vaccinations

DIRECTIONS TO THE HOTEL

Murieta Inn and Spa, located at 7337 Murieta Dr, Sloughhouse/Rancho Murieta, CA, is typically reached via CA-16 (Jackson Road) east from Sacramento. From Sacramento, take US-50 E to CA-16 E, or take CA-99 S to Grant Line Rd to CA-16 E, following signs for Rancho Murieta and turning onto Murieta Dr.

Key Driving Directions: From Sacramento/North: Take US-50 East to the Sunrise Blvd exit. Go south on Sunrise Blvd, then turn left (east) onto CA-16 E (Jackson Rd). Proceed to Murieta Drive.

From South (Stockton/Elk Grove): Take CA-99 North to Grant Line Road. Turn right on Grant Line Road, then turn right (east) onto CA-16 E (Jackson Rd) to Murieta Drive.
